With the proven performance of Advion® fire ant bait, Syngenta is committed to providing effective solutions for fire ant control. By following this specified treatment protocol, Pest Management Professionals (PMPs) can reduce fire ant populations around customers' homes or properties.

Advion fire ant bait provides fast-acting control of fire ants, including the queen. With only one application, it can control foraging worker ants within 12 to 48 hours and provide total colony control within 72 hours. After two applications, year-long colony control can be achieved.

Assurance Offer

Syngenta guarantees at least 90 percent control of active mounds by following the recommended treatment protocol. If PMPs do not achieve at least 90 percent control of active mounds, Syngenta will provide additional quantities of Advion fire ant bait as described in this assurance program. To qualify for the 2017 SecureChoice™ Fire Ant Assurance Program, recommended applications of Advion fire ant bait must be applied between October 1, 2016 and September 30, 2017 ("Program Period").

Protocol

Make at least two applications of Advion fire ant bait approximately four to six months apart (once in the spring and again in the late summer to early fall) at 1.5 lbs./acre or 0.5 oz. (4 level Tbsp.)/1,000 sq. ft. per application. Broadcast applications are the best method to ensure season-long control of fire ants, as they place the bait in the area where fire ants are active and will control mounds that may be small or invisible at the time of treatment.

Advion® fire ant bait	0.045 GR	1.5 lb./acre or 0.5 oz. (4 level Tbsp.)/1,000 sq. ft.	Indoxacarb

For Advion fire ant bait applications using hand-held spreader, rotary push spreader or bottle with shaker-top:

- ▶ Treat fire ant mounds by applying 0.5 oz. (4 level Tbsp.) of product per 1,000 sq. ft., being careful not to disturb the mounds themselves.
- ▶ For larger areas, broadcast the product over the treatment area with 1.5 lbs./acre.
- ▶ Repeat applications in approximately four to six months.

Program Terms and Conditions

- ▶ PMP will follow all label guidelines, recommendations, use rates and treatment protocols as defined in the SecureChoice Fire Ant Assurance Program.
- ▶ PMP will review all program materials with a Syngenta representative or authorized distributor representative prior to PMP participation in the SecureChoice Fire Ant Assurance Program.
- ▶ PMP will agree to provide the following information in the event that a retreatment or retreatments are necessary:
 - The amount of pounds of product per treatment, per account
 - The approximate area treated (acres or sq. ft.) per treatment, per account
- ▶ PMP will agree to work closely with Syngenta territory manager to perform the requirements in the SecureChoice Fire Ant Assurance Program during the Program Period.
- ▶ Some homes or properties may not be ideal candidates for receiving fire ant treatments. Please consider this when discussing fire ant treatment options with customers in this situation.
- ▶ If PMP receives a complaint from an account that requires a retreatment within this SecureChoice Fire Ant Assurance Program, despite following all label instructions and conditions within this SecureChoice Fire Ant Assurance Program, **PMP must contact a Syngenta territory manager within 7 days of the account being retreated.**
- ▶ If Syngenta determines that the retreatment(s) is/are justified, Syngenta will provide the quantity of Advion fire ant bait to cover the retreatment(s) of the account as needed, but no later than October 15, 2017. Syngenta will not pay for the application or other costs associated with retreatment(s).
- ▶ Syngenta reserves the right to investigate each product performance complaint, to verify all purchases or to modify or discontinue this SecureChoice Fire Ant Assurance Program at any time.
